

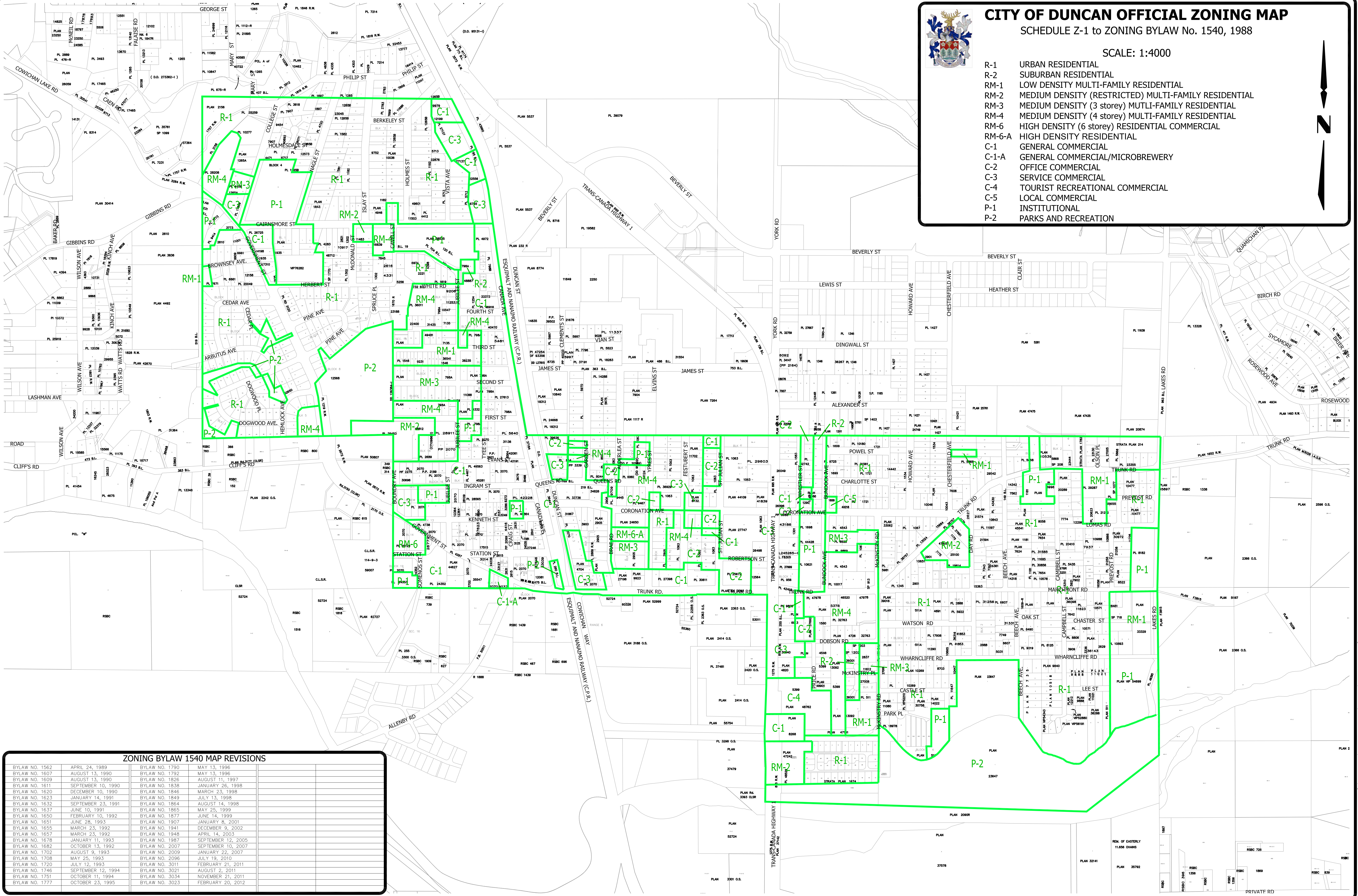


# CITY OF DUNCAN OFFICIAL ZONING MAP
